

Upper Peninsula Region of Library Cooperation, Inc.
Annual Business Meeting
Minutes of the Meeting of September 26, 2018

CONVENE THE BUSINESS MEETING: The annual business meeting of the Upper Peninsula Region of Library Cooperation was held at Bay College in Escanaba. Marc Boucher, Chair, called the meeting to order at 9:19 a.m. Pam Malmsten was appointed to be the recorder of the minutes.

PRESENT: A list of UPRLC members present, along with designated voter status, is listed at the end of these minutes.

PRESIDENT'S REMARKS: Marc Boucher welcomed everyone to the UPRLC Annual Meeting and acknowledged Platinum, Gold, and Silver level sponsors. Marc also thanked organizers from Bay College and the Escanaba Public Library and the UPRLC Annual Meeting Planning Committee. Shawn Andary talked about locations and times for breakout sessions and explained how the door prize raffle would work.

TREASURER'S ANNUAL REPORT:

Pam Malmsten presented the Treasurer's Report. UPRLC is a 501(c)(3) non-profit corporation. Since all of UPRLC's members are schools or libraries, the financial audit is conducted using a governmental, rather than non-profit, format and UPRLC complies with all GASB (Governmental Accounting Standards Board) rules. UPRLC has five separate accounting classes including: the General Fund, the Continuing Education fund, the ALS (automated library services) fund, the NMLN (Northern Michigan Library Network) fund, and the employee PTO (accrued leave) fund.

FY 2016/2017 Financial Audit Summary: On October 1, 2017, total fund balances were \$294,717. The NMLN fund balance was \$0, Continuing Education fund balance was \$2,154, the General Fund Balance was \$2,677, the PTO fund balance was \$9,763, and the ALS fund balance was \$280,123. Page 10 of the Financial Audit, the Statement of Net Position and Governmental Funds, shows that UPRLC member library restricted accounts totaled \$6,146.

UPRLC Financial Summary for Year-to-Date 8/31/2018: The combined ALS/NMLN/UPRLC operating budget as of 8/31/2018 showed year to date revenues of \$372,960 and year to date expenses of \$327,178. The balance sheet as of 8/31/2018 showed total assets of \$362,980.03 and total liabilities plus fund balances of \$362,980.93.

FY 2017/2018 Financial Summary: At the end of FY 2017/2018, anticipated revenues, expenditures, and net income for each fund are:

Continuing Education: revenues of \$4,235 and expenses of \$3,800 resulting in net income of \$435.

General Fund: revenues of \$2,816 and expenses of \$1,675, resulting in net income of \$1,141.

ALS/NMLN Fund: revenues of \$403,163 and expenses of \$388,308 resulting in net income of \$14,855.

Total anticipated net income as of 9/30/2018 is \$16,431.

UPRLC Budget for FY 2018/2019: Total budgeted revenues for all funds are \$404,565 and total expenses are \$399,652. Projected net income for FY 2018/2019 is \$4,913.

ELECTION OF THE FY 2018/2019 BOARD OF DIRECTORS:

Each UPRLC member institution may designate a voting member for the purpose of electing a Board of Trustees. Marc Boucher reminded everyone that voting members were designated with colored stars on their name tags. Current board members are: Megan Buck, Amanda Winnicki, Lisa Cromell, Suzanne Dees, Dillon Geshel, Andrea Ingmire, Mary June, Janis Lubenow, Pamela Malmsten, Lisa Waskin, Leslie Warren, and Marc Boucher. Pamela Christensen resigned from the Board on 9/6/2018 and Dion Mindykowski resigned on 3/20/2018.

Board member Suzanne Dees indicated that she would be resigning from the Board effective October 1, 2018. Board members with terms expiring on 9/30/2018 are: Megan Buck, Lisa Cromell, and Mary June. Megan Buck and Lisa Cromell agreed to run for another term. Vice-chair Megan Buck was notified prior to the meeting that Shawn Andary was interested in serving on the Board. Marc Boucher called three times for additional nominations from the floor; Carolyn Stacey was nominated from the floor.

A motion was made to elect Megan Buck, Lisa Cromell, Shawn Andary, and Carolyn Stacey [all with terms expiring 9/30/2021] to the UPRLC Board of Directors for FY 2018/2019 (MSC Leslie Warren/Amanda Winnicki). Motion carried unanimously.

ADJOURNMENT: There being no further business, the Chair declared the meeting adjourned at 9:45 a.m.
